Please note that minimum freight for the above 4 service level is at 0.5M3 or 500KG per consignment, except for L. Datu & Labuan port, minimum freight at 1M3 or 1000KG per consignment.

For shipment, up to port only, consignee needs to pay local charges to destination agent upon collection of goods from their warehouse, except for Sibu & Bintulu port

Important Notes:

- 1. Shipment of Government Controlled Items requires Had Gerakan, which to be applied by shipper. However, it can be arranged by DCL with a fee of RM150/application.
- 2. Shipment of DG cargo subject to additional DG surcharge. Shipper need to provide MSDS (Material Safety Data Sheet) to get approval from shipping lines.
- 3. Shipment of long cargo with the length of 10 to 15 feet subject to Long Length surcharge at RM 15.00/M3 (minimum RM50.00/shipment). Those exceeded 15 feet, charges to be advised.
- 4. Shipment of personal effect, government controlled items & transshipment cargo, separate declaration is required at Port Klang. Declaration can be arranged by DCL with a fee RM80 / shipment.
- 5. Shipment of timber requires permit from MTIB (Malaysia Timber Industry Board), which to be applied by shipper.
- 6. For shipment to Labuan, delivery to oil and gas area subject to additional handling charges at RM25.00 / M3 (MIN RM250.00/shipment).
- 7. For shipment to Labuan, entrance to Asian Supply Base subject to entrance fee of RM80.00 / entry.
- 8. For shipment to Kuching, delivery to Sama Jaya free industrial zone subject to declaration fee of RM250.00 / Consignment.

Terms & Conditions

- All Cargo shipped must be sea-worthy. We will not be held responsible for any damaged, crushed or lost cargoes during transit. Marine Insurance Coverage – Shipper responsibility to ensure that all goods are adequately insured against "ALL-RISK" whilst all under DCL care, custody or control.
- INSURANCE premium for general merchandise at 0.35% against 110% of invoice value + 6% GST + stamp duty RM 2.00 or Minimum Premium at RM30.00 / Consignment. For shipment that is not cover with insurance, any damages or losses will be fully under own responsibility by shipper or consignee.
- INSURANCE premium for personal effect at 0.75% against 110%% of invoice value + 6% GST + stamp duty RM 2.00 or Minimum Premium at RM350.00 / Consignment. For shipment that is not cover with insurance, any damages or losses will be fully under own responsibility by shipper or consignee.
- Door collection is within Klang Valley & door delivery is within 10 KM radius from Town Area excluding delivery above ground floor level.
- The above rate is excluding heavy lift surcharge (if any), positioning and unpacking of cargo
- Rates applicable for weight or volume whichever is greater.
- Payment Term : CIF / C&F Cash On Delivery
- All goods collected must be within the load space/weight of a 10 tonne truck. Anything out of the ordinary in size, shape or weight is subjected to a surcharge.
- In the event a booking is made, one time pick up will be in accordance to this quote. Any additional trips will be charged according to standard haulage tariff.
- Collection of goods will be as per booking made. Any additional goods added (same day of collection), must notify our Customer Services Department immediately in advance (1day before pickup).

- Shippers' cooperation to provide correct measurement for all their consignment is required in order to minimize consignment being rollover/shutout.
- Labour Charges: RM 80 per-person & per-floor. (For Collect Cargo) {IF REQUIRED}
- The above rates are subject to change with or without any prior notice.
- Please kindly fax return a copy of this quotation with full company endorsement if the rates
 are accepted within seven (7) days from the date stated herein. And however, where no
 acknowledgement of acceptance from your company, we will consider this quotation is
